5) Frequency Coordinator Report - Frank N3FB

There are currently 22 applications that are in the active file. These range from applications that are being processed to ones that have had an initial coordination granted. We have 297 published repeaters and there are 376 active coordinations – these include links and control coordinations. Since July 25th we have issued 3 initial, 2 final coordinations and 1 denial.

6) Committee Reports

a) Technical Committee – Kevin W3KKC

Kevin gave a report on the status of all technical issues. Between him and Frank, all open items are caught up and going through due process. “Things are running smoothly.” We had a few rounds of open discussion and even took on a PL change request in the meeting...

b) By Laws Committee – Jeff N8PSU

While the process is slow, the development of solid language that will carry the WPRC forward is the primary focus. This process removes conflicting language, gives more specific language around membership and organizational function such as establishing standing committees and assistant positions to help process day to day business. Jeff stated that with the organization running smoothly and transparent there are just some minor changes that are needed at this point.

c) Public Relations Committee – Jim N5NWC and Scott N3XCC

Jim N5NWC mentioned that Kevin W3KKC and Scott N3XCC have been handling most PR items but there were some things that he had handled that did not need board involvement. Jim mentioned things are still very quiet.

d) WPRC, Inc. Website update – Scott N3XCC. A new user friendly WPRC, Inc. web site is planned for late 2014 early 2015 launch.

- a) We have issued log numbers 3600 – 3735 since January 1, 2014. 136 items of business.
- b) Tom K3WS opened for discussion the idea of going to a 3 meeting year and then made a Motion that the WPRC, Inc. go to a April, July, and October meeting schedule. Jeff N8PSU commented that the WPRC, Inc. Bylaws stated a minimum of 3 meetings per year and this Motion if approved did not require a change in the Bylaws. Again everyone in attendance had the opportunity to discuss the K3WS motion and a lot of discussion took place. We all learn with communication...
